IN THE MATTER OF JAIL EXPANSION:

Local residents Travis and Owen Bahr and Ray Schweikhardt were present as were Laura Taylor, Executive Director of Phelps County Industrial Solutions; Vickie Jones, PM for Future Care, Inc.; Sarah Skyles, HR Manager of Future Care; Renee Ridling, Executive Director for Gingerbread House; Cindy Wagner, Coordinator for Phelps County Recreation for the Handicapped. At 0905, local residents Dan Sutterfield and H. Mark Eudaly entered. Sheriff Mike Kirn was present as was a local reporter. Despite the scheduled bid opening at 0900, Commissioner Verkamp engaged Kirn—who had a time-sensitive appointment elsewhere—in a discussion of the revenue stream available to pay any bonds related to jail expansion. Kirn believes the revenue stream will be adequate.

IN THE MATTER OF CONTRACT BID HAULING:

The sealed bid from Daniels Construction for contract hauling was opened at 0910. The sole bidder, they submitted \$100/hour. The bid was shared with Acting Superintendent of Roads Mark Case and Michelle Bock, of the Road Department, who entered briefly just after 0900 and left again. The bid was taken under advisement.

IN THE MATTER OF MULTIPURPOSE ROOM USE:

Dan Sutterfield asked about showing the movie, "2,000 Mules" by Dinesh D'Souza at the Multipurpose Room and he wanted to broach the subject with the Commission since there is some controversy. Commissioner Hicks suggested that Sutterfield look into copyright infringements; otherwise, the Commission had no objections. Sutterfield left roughly 0915.

IN THE MATTER OF INCAPACITY ADJUDICATIONS AND VOTING:

Cindy Wagner with Phelps County Recreation for the Handicapped spoke of the 225 individuals they serve in Phelps County with DD; their program is 42 years old. She is unaware of how many of their clients are able to but says those clients are very proud of their ability to vote. Mark Eudaly asked if he could ask questions; responding, the clerk read Mo Const Article VII Section 2. Eudaly said his son has a friend who attained Eagle Scout status who is in this situation. Public Administrator Dana Sooter and Jamie Crump entered at 0920. Jones, who works with Future Care, contributed her comments that some of the people who are adjudicated incapacitated in this way are very diligent about doing their homework before voting; some of the

clients do not use the opportunity to vote. Taylor related that a client could not be accompanied by his parents into the hospital during COVID; parents of this young adult sought guardianship to help them with their circumstance. Ridling spoke to the varied needs of people with guardians, saying some retain the right to vote. She said, "A young woman I know, is under guardianship because she makes horrible decisions with respect to men and terrible decisions about money." Ray Schweikhardt said what is being discussed is the people in the community who are "completely unable to function." The clerk explained her feelings of demoralization due to the state constitution, to which she took an oath, as well as an election law statute, both saying something different than that found in the probate and guardianship chapter. She displayed the very large, text-filled wall poster of the legislative language behind the November, 2018 statewide ballot issues; she said, "It took me an entire weekend to read this. This is what we are asking of voters." When an answer was demanded, she said that individuals with court orders for guardianship which preserved the right to vote had not and would not be deleted. The group made it plain that they felt the clerk was being very prejudicial and unfair, especially shortly before the August 2, 2022 Primary Election. After a few more comments they exited with the reporter at 0955.

IN THE MATTER OF

Strategies for funding roads was discussed.



IN THE MATTER OF
JUNETEENTH:

Treasurer Carol Green and Collector Faith Barnes were present as was the reporter. Assessor Bill Stoltz entered at 0905. Stoltz suggested to Presiding Commissioner Verkamp, when asked, that if Juneteenth (June 19) was a state holiday for which the Circuit Clerk and the Courts would be closed, that the County offices could be closed. Barnes said the same; Green said that in light of her upcoming retirement, she would defer to others. Commissioner Hicks was emphatic in his opposition to using the day as a holiday. Commissioner Auxier wanted to take the item under advisement; Governor Parson was expected to sign one or more pieces of legislation today but it was unclear if the pertinent statute was among them. Michelle Bock of the Road Department entered at 0920 and Green briefly left.

IN THE MATTER OF
ROADS:

Bock reported on culvert replacement on Road 1020. When asked about the Donelson pressure paving proposal, Presiding Commissioner Verkamp said that it wasn't under a cooperative bid. Local resident Chester Kojro entered at 0925 followed by Sheriff Kirn. After a sidebar consultation with Kirn, the reporter left at 0930.

JAIL EXPANSION:

Sheriff Kirn reported that he spoke with a local bank and was informed of an alternative, such as a direct loan. The interest rate is a little higher, but might be adjustable if interest rates go down. Just as Bock left at 0940, Green returned. The banker had said that his bank had 7-8 billion set aside for government loans. If something happened, the loan terms could be modified. There would be no penalty for prepayment, unlike with bond financing. Commissioner Hicks said he was still unclear on the total cost; Kirn said that if it was an addition only, it was \$13 million; if it was an addition with a remodel, it would be \$17.8 million. Kirn feels that without the remodel there will be a need to feed inmates in shifts. Renovation would be an increase from 4 to 12 isolation cells; larger and improved kitchen and laundry facilities. Kirn said that with closure of private facilities, the feds were "begging for facilities." A lengthy discussion ensued about the possibilities, including potentially using funds on hand for the expansion and the CAP grant, still in the approval process, for the remodel. With the CAP grant, the federal government pays a portion or all of the cost of a jail as long as space is reserved for federal inmates.

IN THE MATTER OF
FLOODPLAIN ADMINISTRATION:

The Commission received and reviewed new floodplain guides for distribution to property owners and for the use by Assessor's and Road personnel. These were from MRPC, the Floodplain Administrator for the County.

IN THE MATTER OF
EMPLOYEE INSURANCE:

The Commissioners reviewed the Benefit Performance Report from Groups Benefit Services for the month of May; year-to-date loss ratio is 64% and reserve account balance, available to pay claims, is \$791,270.79.

IN THE MATTER OF
HEALTH DEPARTMENT GRANTS:

Phelps/Maries Health Department Director Ashley Campbell entered at 1055 with several grant documents. She said that the WIC was an amendment for an inadvertent omission of the indirect cost part of the contract, which had been supplied by DHSS. As moved by Commissioner Hicks and seconded by Commissioner Auxier, this was approved. Campbell explained that her department had continued billing for 10% of indirect costs, as this provision had always been in the contracts before. She has a contract with DESE for Safe Cribs; many grant contracts have been moved from DHSS to DESE. This was approved as moved by Commissioner Hicks and seconded by Commissioner Auxier.


IN THE MATTER OF
DOCUMENTATION OF VACATION OF ROAD 7530 AND LAND OPTION:





IN THE MATTER OF JAIL EXPANSION FINANCING:

Local resident Ray Schweikhardt and First State Community Bank President for Rolla/Richland Ernest F. Kost were present. Kost provided some information about his bank and its 58 branches. Sheriff Kirn and Theresa Lasher of the Sheriff's Department as well as Treasurer Carol Green entered at 0902 along with the reporter. Kost proceeded to recount some details of a lease-purchase with the bank, as opposed to financing through the alternative of Certificates of Participation. His bank can offer a tax-exempt loan, which not all banks are able to do. His bank financed the jail building in Pulaski County and sewer district in St. James; the Pulaski County Commissioners might provide a reference. When prompted about the subject by Kirn, Kost said that by state statute this did not need to be bid. He has a government lending specialist on staff at his bank who can be available for more detailed questions. Kost left at 0920. Thereafter, the cap on number of federal inmates and the different interest rates for taxable versus tax-exempt portions were discussed. After providing Presiding Commissioner Verkamp information on the timeline for the project, Kirn and Lasher left at 0930.

IN THE MATTER OF SALES TAX REPORT:

Green presented the sales tax revenues showing \$359,284.88 for the 0.5% county tax, pointing out that the rolling twelve month was down to 9.9% above prior year, compared with 12.5% the prior month.

IN THE MATTER OF AMERICAN RESCUE PLAN ACT (ARPA):

Green said that she had taken the initial steps for the \$4.3 million second tranche of ARPA fiat; Presiding Commissioner Verkamp will be receiving notice for his electronic signature, etc. Green left at 0935.

IN THE MATTER OF COLLECTOR:

Collector Faith Barnes entered at 0935 and reported that she currently had 147 properties which were candidates for the Collector's Delinquent Tax sale. Barnes, and then the reporter, left by 0940.

As moved by Commissioner Auxier and seconded by Commissioner Hicks, the following documents which had been prepared by Attorney J. Kent Robinson, were approved:

ORDER VACATING A PORTION OF COUNTY ROAD 7530 PURSUANT TO
RSMO 228.110

NOW ON THE DATE SHOWN BELOW, the County Commission of Phelps County, Missouri confirms, declares, and determines as follows:

1. On October 2, 2012, the Phelps County Commission, pursuant to and in accordance with RSMo 228.110, publicly read a petition signed by twelve residents of Arlington Township to vacate a portion of Phelps County Road 7530 described as follows:
That portion of Phelps County Road 7530 lying between the North right-of way line of Missouri Stat Highway "P" and a point two hundred twenty-five (225) feet South of the South right-of-way line of the Burlington Northern & Santa Fe Railroad.
2. On said date, the Petition was publicly read, and the matter was thereafter continued without further proceedings until the first day of the next term, that being January 4, 2013.
3. Notice of the filing said Petition describing the portion of the road sought to be vacated was posted in not less than three (3) public places in said township at least twenty (20) days before the first day of the next term of the Commission, and all persons residing in said township whose lands are crossed or touched by the road portion proposed to be vacated acknowledged receipt of said Petition waiving formal service thereof.
4. On January 4, 2013, the first day of the next regular term of the Commission and after the first reading, the said Petition was again publicly read, and a second petition signed by residents opposed to the road vacation was presented, duly discussed, and considered by the Commission, whereupon further action on the Petition to vacate said roadway was tabled until January 17, 2013.
5. On January 17, 2013, the Commission again considered said Petition to vacate a portion of County Road 7530, more particularly described above, and the Phelps County Commissioners unanimously found as follows:
 - a. The entire above-described roadway portion for which vacation is sought lies within the Arlington Township, Phelps County, Missouri.
 - b. The said roadway portion as above described has been closed (as of January 17, 2013) for over two years, needs major renovations and repair and, without such repairs, is otherwise useless to the County and its residents as a roadway.

DOCUMENTATION OF ORDER, VACATION OF ROAD 7530, Continued:

- c. Repairing of the said roadway portion as above described would be an unreasonable burden upon the County Road District within which it lies.
 - d. The property owners to whom the vacated portion of said roadway will revert agreed to rededicate the said roadway, or a mutually agreed upon alternative roadway, back to Phelps County should funds become available in the future to reopen the same to public traffic and should the County be inclined to reopen said roadway and said property owners have provided the County with a signed option in a recordable format evidencing said agreement acceptable to the Commission.
6. In addition to the foregoing and as of the date below, no county aid road trust funds from or through the Missouri Department of Transportation have been used or expended upon that portion of the road for which vacation is sought for a period of more than five (5) years and said road portion has not been used by the public for a period of more than five (5) years continuously, for which reason, pursuant to RSMo 228.190, said roadway portion is deemed abandoned.
7. For reasons unknown, the original order vacating the said portion of County Road 7530, dated January 24, 2013, although duly noted in the regular meeting minutes of the Commission, was not recorded and cannot now be located, for which reason this Order is being now executed for recordation.

FOR THE FOREGOING REASONS, IT IS HEREBY ORDERED AND CONFIRMED BY THE PHELPS COUNTY COMMISSION that the portion of Phelps County Road 7530 more particular described in Paragraph 1 hereof, and pursuant to RSMo 228.110 and 228.190, is deemed, and hereby is, formally vacated and abandoned, and the said roadway portion, as above described shall, in accordance with law, revert back to the property owners whose property adjoins said vacated roadway portion.



IN THE MATTER OF
BRO BRIDGE PROGRAM:

Jeff Banderet, P.E. with Great Rivers Engineering, entered and provided information about Phelps County's current status with this program. Some of the parameters have changed; MoDOT has declared four bridges in Phelps to be eligible for the BRO program:

- On County Road 3620 over a branch of Dry Fork Creek;
- On County Road 7460 over Little Piney Creek;
- On County Road 8410 over Spring Creek;
- On County Road 2110 over a branch of Spring Creek.

The first three were built in 1900; the last in 1946. Banderet said the county might aim for three applications, with one bridge replaced in each of the next three years. The County has \$140,000 in BRO funds and \$18,000 in the soft match account. Jail Lt. Joe Taylor and the reporter were also present, as were Curt Gilliam and Ernie Kost of First State Community Bank. Collector Faith Barnes and Assessor Bill Stoltz entered at 0910. Noting that Boone County had 18 bridges eligible, Banderet said that the County had until late July to complete applications and that the awards would be made in September. Michelle Bock of the Road Department entered at 0920, and after a few more comments, Banderet left at that time.

IN THE MATTER OF
JAIL EXPANSION FINANCE:

Kost deferred to Gilliam who said that, though he was not an attorney, his long understanding was that lending services did not fall under statutory bid requirements. He spoke with an attorney with Gilmore & Bell; the thinking is that there are so many variables in these financing instruments that there is no way to make comparisons, essentially. Local resident Chester Kojro entered at 0925. Kost spoke of the current interest rate volatility. Presiding Commissioner Verkamp said that perhaps acceleration in the pay down period was far more attractive than a low interest rate. Fairly extensive discussion about rates and any potential bid process—which would entrain the volatile rate environment with looming increases—ensued. Recorder Robin Kordes and Phelps/Maries Health Department Director Ashley Campbell entered at 0940. Responding to Taylor's inquiry, Presiding Commissioner Verkamp said that the Commission was awaiting legal opinion from the Prosecuting Attorney. Gilliam, Kost and Taylor left at 0950.
