Shall the Newburg R-II School District of Phelps County, Missouri issue its general obligation bonds in the amount of \$990,000 for the purpose of (1) improving, furnishing and equipping existing school facilities, including heating and cooling system improvements in high school and gymnasium, improvements needed for compliance with Americans with Disabilities Act, constructing addition to join former shop building with two-story high school building to cover ramps and to include new ADA-compliant restrooms, and improvements to kitchen and cafeteria to upgrade and replace equipment, expand dining area and redesign serving area for service efficiency; and (2) purchasing school buses, including ADA-compliant bus. If this

proposition is approved, the adjusted debt service levy of the school district is estimated to remain unchanged from the current debt service levy of \$0.50 per \$100 of assessed valuation of real and personal property.
